

TABLE GAMES REGULATORY PROCESSES: RESPONSIBILITIES OF IGR AND SLGA

A. Process for New Table Games or Amendments to New Table Games (SIGA Table Games Terms and Conditions, Section 3)

Currently both SIGA and SGC are required to submit the rules of play for all table games played at the casinos for approval by SLGA. Through this process, SGC and SIGA are currently operating on approved rules of play. There are differences among the casinos in how games are played. However, these differences are within limits that SLGA finds acceptable.

SLGA has plans to bring the rules of play at the casinos into closer harmony through the creation of a formal set of approved rules of play for the province. These will be referred to as provincial standards.

Pending SLGA's formal adoption of provincial standard rules of play, the current SIGA rules of play are the reference point for regulation of the table games and shall continue to be such for IGR.

Process for new table games or amendments to approved table games

In the event that SIGA desires to add a new table game or change an existing game, the following process shall apply and shall be completed in the following order:

1. SIGA submits required documentation to IGR as required by Section 3 of the Terms and Conditions and identifies casino sites where games would be offered for play.
2. IGR evaluates the submission in accordance with the Table Games Evaluation Procedure in effect at the time as established by SLGA (attached as Schedule 1) and such other analysis as IGR may consider appropriate. SLGA may amend the Table Games Evaluation Procedure from time to time, following meaningful consultation with IGR, and will provide written notice to IGR of any such changes.
3. IGR provides a background report, analysis, and recommendation to SLGA as to whether SIGA's proposal should be accepted or rejected.
4. SLGA evaluates the material provided by IGR and may request additional information as required. Requests for additional information will be made by SLGA to IGR.

5. Upon completion of its review and analysis of IGR's recommendation, SLGA either approves or rejects the table game or the amendment and notifies IGR.
6. IGR shall notify SIGA of the acceptance or rejection of the application, with a copy to be provided concurrently to SLGA.

B. Process for Approval of Disposal of a Progressive Jackpot (SIGA Tables Games Terms and Conditions, Subsection 6(2))

In the event that SIGA desires to dispose of a progressive jackpot other than through the payout of the progressive jackpot at the same table game, the following process shall apply and shall be completed in the following order:

1. SIGA submits the proposal to IGR as required by subsection 6(2) of the Terms and Conditions.
2. IGR evaluates the submission.
3. IGR provides an analysis and recommendation to SLGA as to whether SIGA's proposal should be accepted or rejected.
4. SLGA evaluates the material provided by IGR and may request additional information as required. Requests for additional information will be made by SLGA to IGR.
5. Upon completion of its review and analysis of IGR's recommendation, SLGA will either approve or reject or require revisions to the proposal.
6. IGR shall notify SIGA of the acceptance or rejection or required revisions to the proposal, with a copy to be provided concurrently to SLGA. In the event, that revisions are required, IGR shall require SIGA to re-submit the proposal and steps 2 through 6 shall be repeated.

C. Process for Approval of Security Policies (SIGA Table Games Terms and Conditions, Section 18) ^{jc} ^{BM}

In the event that SIGA desires to modify or replace its existing plan referred to in section 18, the following process shall apply and shall be completed in the following order:

1. SIGA submits the revised plan to IGR as required by section 18 of the Terms and Conditions.
2. IGR evaluates the submission.

3. IGR provides an analysis and recommendation to SLGA as to whether SIGA's proposal should be accepted or rejected.
4. SLGA evaluates the material provided by IGR and may request additional information as required. Requests for additional information will be made by SLGA to IGR.
5. Upon completion of its review and analysis of IGR's recommendation, SLGA will either approve or reject or require revisions to the proposed plan.
6. IGR shall notify SIGA of the acceptance or rejection or required revisions to the plan, with a copy to be provided concurrently to SLGA. In the event, that revisions are required, IGR shall require SIGA to re-submit the revised plan and steps 2 through 6 shall be repeated.

D. Process for Monitoring SIGA's Compliance with Terms and Conditions

1. Inspection Process and Reporting Guideline

On a quarterly basis, IGR and SLGA will carry out joint inspections of table games at each SIGA casino and jointly ensure the completion of the inspection checklist with supporting documents. A joint inspection means that each of IGR and SLGA review and ensure completion of all items on the Table Game Inspection Checklists in effect at the time (attached as Schedule 2). The Table Game Inspection Checklists may be amended from time to time by SLGA following meaningful consultation with IGR.

IGR and SLGA may carry on such other joint or independent inspections as considered appropriate.

IGR will provide SLGA with:

- (a) any observations with respect to cheating at play and advantage players immediately;
- (b) monthly reports that summarize the inspections conducted by IGR in the preceding month, to be provided by the 15th of each month; and
- (c) comprehensive quarterly reports that include inspection reports and supporting documentation, to be provided by the 15th of the month following the end of the quarter.

IGR will prepare and provide to SLGA, IGR's proposed quarterly letter to SIGA, at least five business days prior to its intended issuance to allow SLGA the opportunity to comment on its contents. Thereafter, IGR shall provide SLGA with a copy of IGR's quarterly letter to SIGA, concurrently with its issuance to SIGA.

2. IGR Workplan

IGR will provide to SLGA:

- (a) on or before September 1st of each year, its plan for casino visitations (proposed number of visits and to which casino) for the upcoming fiscal year; and
- (b) at least 2 weeks prior to the start of each quarter of the fiscal year, its updated plans for casino visitations for the next quarter.

IGR's casino visitation plan should indicate how IGR will ensure each area of the terms and conditions will be evaluated during the course of the year.

3. Observations of Underage, Intoxicated, Banned Persons

IGR will immediately report to SIGA security any instances where it observes any underage, intoxicated or banned persons in the table games area and record any such occurrences in its monthly and quarterly reports. The role of IGR staff that observes such occurrences is to advise SIGA security staff and not to directly intervene with the underage, intoxicated or banned person.

4. Malfunctioning Equipment

IGR will immediately report to SLGA any instances of malfunctioning equipment related to table games or table games surveillance and record any such occurrences in its monthly and quarterly reports.

E. General provisions

1. Process Review

SLGA and IGR may make any mutually-agreed-upon changes to these provisions as agreed to from time to time by SLGA and IGR in writing. In addition, IGR and SLGA shall conduct and complete a joint review of the process for monitoring SIGA's compliance prior to the third anniversary of the Licensing Agreement. In the event that SLGA and IGR are unsuccessful in reaching mutual agreement on changes to the inspecting and reporting provisions, the provisions in effect at the time will remain in full force and effect.

2. SLGA Continued Access to Table Games Area

SLGA retains the authority to make observations of the table games as part of its responsibility for the overall casino and as part of the ongoing post-delegation capacity evaluation of IGR.
